

# Medicines for Europe gears up for Ukraine's future accession to the EU

Medicines for Europe met today in Brussels with a high level Ukrainian government delegation led by Maryna Slobodnichenko, Deputy Minister of Health for European Integration. Medicines for Europe put forward ideas on how to plan for the future integration process which requires a lot of regulatory and market policy alignment including:

- Supporting the creation of a dynamic medicines agency with help and expertise from leading agencies in EU Member States and to encourage alignment with the regulatory standards and requirements for marketing authorisations .
- Learning from experience with other EU partners regarding Good Manufacturing Practice (GMP) recognition which is a pre-requisite for supplying medicines.
- Accelerating the alignment of digital regulatory requirements such as electronic Product Information (ePI), electronic Common Technical Document (eCTD) and access to the EudraGMDP\* database all of which are needed for the modern oversight of medicines regulation.
- Ensuring Ukraine's rapid integration into EU safety systems, such as the European Medicines Verification System (EMVS) to fight against falsified medicines.
- Medicines for Europe is a committed partner with the EBA\*\* of Ukraine to accelerate regulatory alignment and integration on medicines with Ukraine to support the country's rapid and effective accession to the EU.

Adrian van den Hoven, Director General of Medicines for Europe said: *“While we maintain our steadfast engagement to help address medicine shortages or availability problems in Ukraine\*\*\*, it is time to move into the next phase of our relationship. Pharmaceutical regulation will be a complex part of the Ukrainian accession process. We need to start working now to accelerate this process with step by step integration into EU data and regulatory systems which will improve patient access to medicines in line with EU safety, quality and efficacy standards.”*
